Panelists from Brigham and Women's Hospital, Franciscan Children's Hospital, Lahey Hospital & Medical Center, Dana Farber Cancer Institute, and Cambridge Health Alliance will discuss, among other items:

- security personnel, hiring, training, competence and culture
- state of the art security technology designed to fit the risk
- strong policies and procedures to address and reduce vulnerabilities
- robust training programs (e.g. managing disruptive behavior, healthcare violence) for the entire healthcare community
- crime prevention techniques and response capabilities
- improvement through use of data
- statistical trending, compilation, analysis and communication of incidents and "near misses"

III) Workforce Engagement

Panelists from Boston Children's Hospital, South Shore Hospital, Baystate Health, MGH, and MedXcel will discuss:

- employee engagement
- exercise scenarios and drills
- new employee orientation for security and risks
- training requirements yearly
- strong partnerships with security
- easy and comfortable reporting system with clear criteria

IV) Recognition, Wellness & Resilience - Caring for the Caregiver

Panelists from MHA, The Schwartz Center for Compassionate Healthcare, Berkshire Health Systems, and UMass Memorial Health Care will discuss:

- how to acknowledge the valued contributions of hospital staff and support them with resources to enhance the safety of their work environment and wellbeing.
- successful strategies and programs
- proactive and reactive methods
- resources
